THE GLACIERS ARE BACK! - CREATING THE ICE AGE EXHIBIT AT THE CINCINNATI MUSEUM CENTER – Tuesday, September 2, 2014, 7:30 p.m., OSU-Lima Visitor Center, Lima

Welcome the Ohio Historical Society's new curator of natural history, David L. Dyer for a fascinating behind-the-scenes look at how a major museum exhibit is created, from research to final installation. See how the empty Union Terminal Building in downtown Cincinnati was transformed into the Ice Age landscape of Ohio over a period of four years. This visually-oriented presentation will show the creation of the life-size tongue of a glacier, including a walk-through ice cave complete with chilly breezes and a waterfall. The photographs will also document museum artists creating life-size scientifically accurate sculptures of large Ice Age animals, a tour of the walk-through glacial outwash plain, the painting of a detailed 4,000 square foot mural of the Ice Age landscape which took over 2 years to complete, and the casting and building of large mammal skeletons – from a saber-tooth to a mastodon.

Milt Miller, GLSM Restoration Manager, will lead a two hour field trip beginning at 10 a.m. at the Auglaize & Mercer Counties Convention & Visitors Bureau, 900 Edgewater Dr., St. Marys, OH 45885 (immediately across from the state park office on the north side of the lake) where Milt will give a general overview of all that is being done to restore GLSM and then we will travel over to the Prairie Creek Treatment Train (PCTT) for an hour tour ending around noon. Participants will carpool departing at 9 am from the Eastgate parking lot behind Wendy's on SR 309, Lima, or may meet the group there at 10 am. MYEERAH WORK DAY – Saturday, October 4, 2014, 9 a.m. to 3 p.m. (8:00 a.m. if you wish to car pool from Lima), Bellefontaine, Ohio

The autumn olive which heavily infests the dam of the little pond at Myeerah poses a threat to the stability of the dam. It is not an immediate danger, but needs to be addressed before it becomes a bigger problem. The goal for this work day is to clear all the woody vegetation on the east side of the dam and to treat the stumps with herbicide. A chipper truck will be manned by city of Bellefontaine employees during the work day. US Fish & Wildlife will assist in seeding the area to grasses after it has been cleared. This is a chance to contribute to the enhancement of the property at Myeerah. There must be at least 8 volunteers working for things to run smoothly. 4 people will be needed to drag the freshly cut brush to the chipper truck, 2 very experienced chain saw operators are needed to cut the autumn olive brush, and two people are needed to spray herbicide on the freshly cut stumps. Lunch and beverages will be provided. Wear sturdy shoes and bring gloves. Dress for the weather. PROGRAM – LIVE RAPTORS – Tuesday, October 7, 2014, at 7:30 p.m., OSU-Lima Visitor/Student Services Center Diane Myers of the Black Swamp Raptor Rehabilitation Center will present a very interesting and educational program when she brings a live Bald Eagle, hawk, falcon, and owl to this month's meeting. This will be a very special opportunity to see these raptors up close. You'll see how they are similar and how they are different. The Black Swamp Raptor Rehab program was first established in 1989. In addition to the many educational programs to public and school groups, the program continues to provide care facilities and is devoted to the first aid and release of injured or orphaned birds of prey. The Black Swamp Raptor Rehab is fully licensed by the U.S. Fish and Wildlife Service and the Ohio Dept. of Natural Resources to rehabilitate and release injured birds of prey. This program, co-sponsored by the Johnny Appleseed Metropolitan Park District, is free & open to the public.

ANNUAL RECYCLE FUNDRAISER - Saturday, October 11, 2014, will be our 21st year operating **Wapakoneta's Drop-off Center**. Volunteers work 8 a.m. until noon. The center is open to the public **9 a.m. until noon**. TMAS receives the proceeds from all recyclables handled. Proceeds are dependent on the volume of materials handled and market conditions. Aluminum cans pay best. Wapakoneta accepts #1, #2, #3, #5, and #7 plastics. No oil containers or pesticide bottles. You can leave the labels on clean tin cans. Also accepted are computers, modems, printers, other computer components, strings of outdoor/indoor decorative lights (bulbs included), shoes (each pair tied together, no heels over 2 inches, and no boots), and regular latex paint in liquid form, any size can, all colors (if paint is hard and dry it goes in regular trash). Twenty-five volunteers are needed to sort items and unload vehicles. Sorters work on an adjustable feed conveyer belt. 2014 ANNUAL APPEAL INTERIM RESULTS - Once a year, Tri-Moraine Audubon Society, an all-volunteer, nonprofit 501(c)(3) organization, asks for the financial support of members and friends to help the chapter fulfill its mission. This year, givers could designate their gift for 1) Area of greatest need, 2) Camp Myeerah or 3) Grand Lake St. Marys. A total of \$25,175.00 has been raised as of August 21, with the majority of donations going to Camp Myeerah, 450 acres in Logan County, now protected in perpetuity for public use and enjoyment. Members and friends can be proud of the chapter's achievement to this end. This report only covers Myeerah, one of six Important Bird Areas in the chapter's 8-county service area. Our next newsletter issue will update the donor list and cover the remainder of the annual appeal distributions.

The sum of \$22,000 in annual appeal donations has been given to the Bellefontaine Joint Recreation District for Myeerah use. BJRDC Director Kris Myers thanks TMAS for the chapter's enthusiastic support plus invaluable financial assistance. Funds have paid for a new roof for the lodge, well repairs needed to make the water system functional, new upright commercial refrigerator and freezer for the lodge kitchen, basic lodge kitchen needs such as pots and pans, a microwave oven, stainless steel tables, a shelving unit, updates to lodge light fixtures to improve the looks of the dining area, refinishing of the lodge floor, dormitory stove, and the list goes on. The chapter added \$6,000 to the annual appeal funds and 50 camp foam floor mattresses for the dorm and round and rectangular tables for the lodge and dorm were purchased plus other smaller items. TMAS also purchased a used refrigerator for the dorm. Our thanks to Don Rosenbeck who obtained a donation of wood for picnic tables from Lowe's of Bellefontaine and supervised the table assembly at Environmental Education Weekend. We thank Lowe's for their support of Myeerah.

Current Myeerah projects are additional clearing of trails, rehabbing of the shelter houses, painting of the lodge inside and out as time and funds permit, and signage placement. TMAS has been awarded a \$2,259 signage grant from National Audubon's IBA Small Grants Program for Myeerah. Future needs include two bridge repairs and improvement and expansion of parking areas.

WATCH THOSE RENEWAL NOTICES FROM NAS; The National Audubon Society (NAS) does not include membership expiration dates on its renewal notices. Look in the upper right-hand corner of the mailing label on your chapter newsletter. If it reads “10/17 M”, that means that your NAS dual membership expires in October of 2017. If it reads “04/15 SM”, that means that your local supporting membership expires in April of 2015. If you want to pay your dual membership way ahead, that’s your call, but the chapter is receiving dual membership expiration dates from NAS extending out to 2023.

PRESIDENT’S MESSAGE

Please check the calendar of events for field trips and special programs this fall. Your officers and field trip chairperson have put thought and effort into finding a wide variety of interesting programs for your enjoyment and education. We hope you can join us on some of our field trips and at our regular program meetings.

One field trip I would like to highlight is a trip to the Grand Lake St. Marys (GLSM) Water Treatment Train Habitat and Wetlands on September 20. This new area is part of the multi-pronged approach to solve some of the toxic algae issues at GLSM. In an effort to create a man-made filtering sequence leading up to a natural filtering wetlands at the south side of GLSM, a natural habitat for wildlife was also created. A real surprise has been the speed of renewal for all sorts of wildlife (ducks, geese, egrets, deer, and many frogs and snakes) returning to the area. With food sources and nesting locations nearby, it has attracted many bird species yet to be documented. A Bald Eagle nesting in the area is not far away. Plans are in place to establish Phase Two of the Water Treatment Train and on the field trip we should see what those plans comprise and see how Phase One is doing after two full years of operation.

St. Marys River - Grand Lake St. Marys is one of six Important Bird Areas in our region. Some Audubon members earmarked GLSM to receive funds from their 2014 Annual Appeal donation. Learn more about how TMAS supports conservation and habitat restoration at this field trip event September 20.

For those of you following the Minnesota Vikings new stadium controversy, be sure to read the article “Why Should Birders Be Worried About the New Vikings Stadium?” in the July-August issue of AUDUBON or follow Audubon Magazine on Facebook. The Minnesota Vikings new stadium could kill thousands of migratory birds unless stadium builders take immediate action to incorporate bird safe measures. You may be able to help urge builders to incorporate a better bird-safe glass into their current plan.
