31st ANNUAL ENVIRONMENTAL WEEKEND

April 30-May 2, 2010

Tri-Moraine Audubon Society will hold its 31st annual Environmental Education Weekend at Camp Myeerah, SR 540 near Bellefontaine on April 30th through May 2nd. This weekend provides an opportunity to learn about and experience nature in a truly unique environmental setting. Camp Myeerah is comprised of nearly 500 acres of diverse habitat with meadows, lakes, streams and woodland. Camp Myeerah is one of 66 sites in Ohio which has been designated as an Important Bird Area (IBA). www.audubon.org/chapter/oh/oh/ibas.html

The education programs offered will include hands-on opportunities to learn and participate in field trips on birdwatching, wildflowers, stream/pond ecology, woody plants and other nature related programs. Timed to coincide with the spring migration of neotropical migrant warblers and the spring wildflowers, the weekend will provide a truly unique family oriented educational opportunity!

The weekend begins with registration starting at 5:00 PM on Friday, April 30th and ends on Sunday afternoon, May 2nd. All meals are provided for Saturday and Sunday. Camping options include **tree houses** which sleep 6 people and have sleeping pads on the floor, **platform tents** which have sleeping pads for 4, and **covered wagons** which have sleeping pads for 5. You may also bring your **own tent** to pitch near a small pond. **Dormitory accommodations** are available, if you prefer the option of a heated building with full restroom facilities.

Due to insurance considerations, this opportunity is **available for National Audubon members (or TMAS local Supporting members) and their immediate families only**. SPOTLIGHT ON EDUCATION

AUDUBON ADVENTURES for 2009-2010

Audubon Adventures (AA) is a National Audubon Society program that publishes educational materials about birds, wildlife, and their habitats for students in grades 3-6. These full-color materials include a classroom resource manual for the teacher and unit newspapers for each student. This year's edition is titled "Action for Planet Earth" and explores earth science topics from a conservation perspective. The focus is on energy, water, habitats, and getting involved in community projects for the good of the planet, the community, and individuals. AA integrates reading with science and other core disciplines and meets national and Ohio standards for science and language arts. Creative teachers can use AA in the classroom in myriad ways. TMAS has supported the AA program since its inception in 1984.

Tri-Moraine ordered 51 AA classroom resource kits for the 2009-2010 school year. We thank the following for their contributions in support of this outstanding program: Ann Beat - AA teacher, St. Girard School, Lima; Benjamin Logan Local School District, Logan County; Celina City School District, Mercer County; and the Walter James "Jim" Wright Memorial Fund in support of Allen County classrooms.

The Tuesday, October 5, monthly program meeting will feature "Owls" by Jim McCormac. Jim is the avian specialist for the ODNR's Division of Wildlife and always gives a spectacular presentation.....On Saturday, January 23, Eric Broughton and I attended the reorganization of COAC (Council of Ohio Audubon Chapters) in Columbus at the Grange Insurance Audubon Center. 2009 CHRISTMAS BIRD COUNT RESULTS

Although the weather was far from promising as the TMAS crew arrived at McDonalds in St. Marys for the Grand Lake CBC on Saturday, 19 December 2009, we have seen worse. The temperature during the day ranged from 28-34 F, but the 7-12 mph winds, generally from the northeast, made it feel colder than that. Water was mostly frozen, skies were cloudy all day, and there was from 0 to 2 inches of snow on the ground, with flurries or light snow most of the day. There were 13 counters, in 5-6 groups: Curtis Gingerich and Timothy Schlabach (Belle Center); Don and Mary Rosenbeck (Jackson Center); Andrew and Jackie Augustine, and Michael Miracle (Lima); Allison Brady (New Bremen); Eric Juterbock [coordinator] (Rushsylvania); Bill Angel, Jill Bowers, and Frank Kuhlman (St. Marys); and M. L. (Doc) Stephenson (Wapakoneta). We spent 24.3 group hours in cars covering 277.2 miles, and 12.75 group hours on foot over 15.2 miles, between 0800 and 1730 hrs.

We recorded the following Grand Lake (GL) birds (new species or record high numbers for the last 21 years are bolded): **Double-crested Cormorant, 1**; Canada Goose, 2726; Mallard, 432; Hooded Merganser, 1; **Shinned Hawk, 1**; *Accipiter*, sp., 1; Red-tailed Hawk, 16; hawk, sp., 1; Amer. Kestrel, 19; Ring-billed Gull, 37; Herring Gull, 20; gull, sp(p)., 309; Rock Pigeon, **307**; Mourning Dove, 256; Red-headed Woodpecker, 1; Red-bellied Woodpecker, 9; Downy Woodpecker, 23; Hairy Woodpecker, 1; No. (Y-S) Flicker, 3; woodpecker, sp(p)., 3; Blue Jay, 27; Amer. Crow, 16; Horned Lark, **812**; Carolina Chickadee, 20; chickadee, sp(p)., 16; Tufted Titmouse, 14; White-breasted Nuthatch, 17; Brown Creeper, 8; Carolina Wren, 1; Golden-crowned Kinglet, 4; No. Mockingbird, 1; **Gray Catbird, 1**; Cedar Waxwing, 8; Euro. Starling, **4207**; Amer. Tree Sparrow, 100; Song Sparrow, 19; Field Sparrow, 8; sparrow, sp(p)., 29; Dark-eyed (S-C) Junco, 110; Lapland Longspur, 30; No. Cardinal, 92; Brown-headed Cowbird, 2; House Finch, 13; Amer. Goldfinch, 42; and, House Sparrow, **1338**. This is 43 species and 11148 individuals.

2009, for the Indian Lake CBC. Five counting groups included: Ralph Shively (Bellefontaine); Evelyn Prater (Harrod); David Bohla (Indian Lake); Don and Mary Rosenbeck (Jackson Center); Andrew and Jackie Augustine (Lima); Eric Juterbock [coordinator] (Rushsylvania); Bill and Sally Angel (St. Marys); and, Brianna Braun, Dianne Knipp, Troy Shively and M. L. (Doc) Stephenson (Wapakoneta). Winds were from the southwest at 4-9 mph, with temperatures 25-31 F. There was very little open water (ice covered most of the lake and much of small streams), 0-3 inches of snow on the ground, and it was mostly cloudy all day (briefly partly sunny in late afternoon). We covered 358 miles in 29 group hours by car, and 7.35 miles in 8 group hours on foot, between 8 a.m. and 5:15 p.m.

We recorded the following Indian Lake (IL) birds (conventions as above): Canada Goose, 1390; Mute Swan, 1; Amer. Black Duck, 4; Mallard, 411; **Common Merganser, 2**; duck, sp(p)., 40; Great Blue Heron, 1; Bald Eagle, 1; **Red-tailed Hawk, 33**; Amer. Kestrel, 39; Amer. Coot, 2; Ring-billed Gull, 332; Rock Pigeon, 119; Mourning Dove, 628; E. Screech Owl, 1; Red-headed Woodpecker, 1; Red-bellied Woodpecker, 37; Downy Woodpecker, 66; Hairy Woodpecker, 7; No. (Y-S) Flicker, 6; woodpecker, sp., 1; Blue Jay, 58; Amer. Crow, 103; Horned Lark, 755; Carolina Chickadee, 36; chickadee, sp(p). 16; Tufted Titmouse, 33; White-breasted Nuthatch, 34; Red-breasted Nuthatch, 3; Brown Creeper, 5; Golden-crowned Kinglet, 2; Hermit Thrush, 1; Amer. Robin, 3; No. Mockingbird, 6; Euro. Starling, 1803; Cedar Waxwing, 8; Amer. Tree Sparrow, 202; Field Sparrow, 20; Song Sparrow, 26; Swamp Sparrow, 10; White-throated Sparrow, 12; White-crowned Sparrow, 5; sparrow, sp(p)., 10; Dark-eyed (S-C) Junco, 71; No. Cardinal, 126; Snow Bunting, 1; Lapland Longspur, 4; Brown-headed Cowbird, 17; Common Grackle, 3; House Finch, 49; Amer. Goldfinch, 61; and, House Sparrow, **1997**. This is a total of 50 species, and 8611 individuals.

There were several record high counts for specific species, as well as new species recorded, based upon the records I have for the last 21 years. In most cases these are likely due to the relatively short time span for which my records extend. One exception is the cormorant at GL, but they have been recorded previously at IL, and they have been getting steadily more numerous and often problematic in the area. The high numbers with pigeons, starlings and house sparrows are clearly a result of catching the right time to pass by landfills and feedlots. As one example, Curtis, Timothy and I were very conservative in tallying 1000 starlings at a feedlot across the road from the landfill south of Celina on a second trip around the block. and we saw none the first time. Overall, the number of both species and individuals at IL were in the top quartile; GL species count was rather low (and a little over 20% below last year), but the number of individuals was a record high. Not bad for the December weather we were having.

Thanks to all of the volunteers. keep your binoculars handy!

Failure to follow these policies shall result in corrective action that may include expulsion from the campground and may affect future registration for EEW programs.
